



**Designated Charitable Beneficiaries
City of Tulsa and Park Friends Funds**

Contributions to Park Friends, Inc. are administered by Tulsa Community Foundation, a tax exempt section 501(c) (3) nonprofit organization, through various charitable fund accounts. Park Friends contributions benefit parks and may be further designated for operations, programming, maintenance and improvements. Charitable component funds of TCF and contributions to Park Friends are fully tax deductible less the estimated value of goods.

Distributions can be made directly to vendors to complete construction and/or maintenance activities, to units of government or to charitable organizations. Project and activity sites will most likely be parcels of land in the existing park systems, other City of Tulsa-owned and/or managed properties (such as highway or utility right-of-ways and storm water detention facilities), or similar and/or private (donated or loaned) land dedicated to such purposes.

The burdens of government will be lessened via expenditures from these Funds, as the City will not have to pay for all the expenses related to the construction and maintenance of the park projects described below or for the charitable community activities that take place at one or more of the City's parks and recreation sites as detailed below. These Funds are not created for any specific class of people, nor an association, nor any other class that is closed to the public. The sole beneficiaries of these Funds are the people of the City and County of Tulsa.

Distributions from these Funds shall be used for the defined purposes below. There are currently twenty two active City of Tulsa Park Friends Funds and ten active Tulsa County Park Friends Funds.

Fund Descriptions and total donations for the past five years (2010 through May 2015) are listed below;

Biscuit Acres Dog Park

This Fund will support the activities at and the construction, expansion, enhancement and/or maintenance of Biscuit Acres Dog Park. This Fund will enhance the quality of life and the quantity of outdoor experiences for City of Tulsa residents.

Chapman Green Oil Capital Project Fund – This Fund for the purpose of supporting design and construction costs for thematic features in the H.A. Chapman Centennial Green located in Tulsa, Oklahoma to commemorate Tulsa’s found oil company history and moniker as “Oil Capital of the World”. Project features may include replicas of original Tulsa oil company logo signs and a former Tulsa downtown gateway; and a thematic art component. Narratives characterizing the enhancements and Tulsa’s overall oil related history will be portrayed on plaques.
